Records are not to be used to compile or prepare mailing lists, marketing aids, classified directories, classified advertising conveyed by any telephonic, mechanical or electronic means, or any other types of compilations that are sold or otherwise provided to third parties

Cancellation policy: Any order may be cancelled prior to shipment with no penalty. ***Once an order has shipped, there are no cancellations!*** We often send our lists in electronic format via email, and once it has shipped, we assume you are going to use it. So please be sure you are ordering the correct list. We are happy to send samples of any list for your review, free of charge, prior to an order.
